I. INTRODUCTIONS:

III. BID OPENING:

Mike Hansen stated that the bids will be received by the Purchasing Office, until 2:00 pm., March 29, 2022 and publicly opened at 2:05 pm, March 29, 2022. BIDS RECEIVED AFTER THE DATE AND TIME SPECIFIED WILL BE REJECTED. The last day for submitting questions is March 15, 2022 by 1:00 pm with responses posted by 12:00 pm March 16, 2022. All questions shall be emailed to Connie Gibson.

IV. CONTRACTOR'S BID PACKAGE:

Mike stated that the Contractor's bid package is located in the upfront portion of the Project Manual. E-Mail and facsimile responses will be rejected. It is the responsibility of the bidder to ensure timely and correct delivery of the bid. BIDS RECEIVED AFTER THE DATE AND TIME SPECIFIED WILL BE REJECTED.

V. BRIEF DESCRIPTION OF PROJECT:

The existing bridge was built in the 1930's by the Civilian Conservation Corp. This project involves dismantle and remove portion of existing structure with the abutments remaining in place. Install new suspension cable and floor beam hanger systems. Replace timber floor beams, stringers, decking and rail system. Maintenance item consists of repointing masonry joints with locations determined in the field by the Engineer.

VI. MAINTENANCE OF TRAFFIC:

The Contractor shall close bridge to pedestrian traffic in a manner to protect pedestrian and vehicular traffic through or around areas of construction. This item includes all costs associated with barricading the work areas from pedestrians and motorists. Maintenance of Traffic lump sum bid item also includes furnishing, fabricating, and installing the posted weight limit sign at both abutments as shown on page 3 of the contract drawings.

VII. TIME OF COMPLETION & LIQUIDATED DAMAGES: This is a "Fixed Completion Date" contract with the "Fixed Completion Date" being 145 days after effective dated of the "Notice to Proceed". The liquidated damages for delay beyond the allotted time for completion of this project shall be \$1500.00 per day for each consecutive calendar day, including weekends and holidays, that the work remains incomplete.

VIII. ANSWER CONTRACTOR'S QUESTIONS:

- Are the railing cross braces shown in the "Transverse Section" on sheet 4 of the contract drawings required at the floor beam location only? No, the railing cross braces will be required at every railing post location.
- Are the timber floor beams shown in the "Transverse Section" on sheet 4 of the
 contract drawings required at every rail post location? No, the location of the timber
 floor beams is shown in the "Developed Section Along Center line" detail located on
 sheet 2.
- Will the Contractor be given sufficient time before the "Notice To Proceed" is issued
 to order the required lumber do to the current conditions impacting supply? Yes, the
 Contractor will be given an amount of time, within reason, to order materials before
 the "Notice To Proceed" is issued.
- Is there an area immediately adjacent to the structure for a lay down area? Yes, the County will provide a lay down area, however the Contractor shall return the area to as good or better condition after the project is completed at no cost to the County.
- Re-pointing of masonry joints will be determined in the field by the Engineer once construction has begun.
- Entry into Sycamore Creek will not be permitted.

- Is Abutment B accessible to vehicles? Yes, there is a road leading to Abutment B which the Contractor can access the abutment however the Contractor shall return the road to as good or better condition after the project is completed at no cost to the County. Justin verified that there are no structures with weight restrictions prohibiting access.
- The County has allowed the Contractor use of the electrical services located at the public restroom near Abutment A
