The Pittsylvania County Department of Public Works is pleased to present the 2021 Annual Water Quality Report (Consumer Confidence Report - CCR) as required by the Safe Drinking Water Act (SDWA). This report is designed to provide details about where your water comes from, what it contains, and how it compares to standards set by regulatory agencies. This report is a snapshot of last year's water quality. We are committed to providing you with information because informed customers are our best allies. Our goal is always to provide you with a safe and dependable supply of drinking water. WHERE DOES MY WATER COME FROM?

The source of your drinking water is groundwater drawn from two (2) drilled wells. The groundwater is treated with the addition of soda ash for pH adjustment for corrosion control for the subject waterworks.

SOURCE WATER ASSESSMENT AND ITS AVAILABILITY

A source water assessment of our system was conducted in 2003 by the Virginia Department of Health. The wells were determined to be of high susceptibility to contamination using the criteria developed by the state in its approved Source Water Assessment Program. The assessment report consists of maps showing the source water assessment area, an inventory of known land use activities of concern, and documentation of any known contamination within the last 5 years. WHY ARE THERE CONTAMINANTS IN MY DRINKING WATER?

All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the Environmental Protection Agency's (EPA) Safe Drinking Water Hotline (800-426-4791). The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or the result of oil / gas production or mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.



IS MY WATER SAFE? DO I NEED TO TAKE SPECIAL PRECAUTIONS?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/Centers for Disease Control (CDC) guidelines on appropriate means to lessen the risk of infection by Cryptosporidium and other microbial contaminants are available from the Safe Water Drinking Hotline (800-426-4791).

KEEP AN EYE ON YOUR WATER SYSTEM

With vandalism and terrorism in the world becoming an increasing concern, we are asking that you be vigilant. Please report any suspicious activity that you might see or encounter to the Pittsylvania County office at 434-432-7135 or call the Sheriff's Department. This can be as simple as spotting someone other than the fire department getting water from a fire hydrant, non-County staff tampering with a meter or suspicious activity at a water tank or our booster (pumping) stations.

PROTECTING THE SOURCE OF YOUR DRINKING WATER

Protection of drinking water is everyone's responsibility. You can help protect your community's drinking water source in several ways:

- Eliminate excess use of lawn and garden fertilizers and pesticides they contain hazardous chemicals that can reach your drinking water source.
- Pick up after your pets.
- If you have your own septic system, properly maintain your system to reduce leaching to water sources or consider connecting to a public water system.
- Dispose of chemicals properly; take used motor oil to a recycling center.

HELP US PROTECT YOUR WATER SYSTEM - BACKFLOW PREVENTION

As required by the Virginia Department of Health (VDH), Pittsylvania County must establish and enforce a Cross Connection Control and Backflow Prevention Program. The purpose of this program is to protect the Pittsylvania County drinking water system from contamination as a result of any cross-connections made to or backflow entering the water distribution system. A "cross-connection" is any connection between your drinking water and a source of contamination. An example is a lawn irrigation system connected to both the public water system and another water source, like a well. A "backflow" can occur with a sudden loss of system pressure or an increase in pressure on the customer's side of the meter. If either happens, contaminants can be sucked in the public water system. Hoses left submerged in swimming pools, kitchen sinks, bath tubs, animal watering troughs, or having chemical sprayers attached to them while weed-killing are conditions that can be very hazardous or in extreme cases, death.

Pittsylvania County and you, the consumer, have a shared responsibility for water quality. As part of our program, we must survey our customers each year to determine if we are still adequately protecting our water supply. WATER CONSERVATION TIPS

Did you know that the average U.S. household uses approximately 400 gallons of water per day or 100 gallons per person per day? Luckily, there are many low-cost and no-cost ways to conserve water. Small changes can make a big difference. Try one today and soon it will become second nature:

- ◆ Take short showers a 5 minute shower uses 4 to 5 gallons of water compared to up to 50 gallons for a bath.
- Shut off water while brushing your teeth, washing your hair and shaving and save up to 500 gallons a month
- Use a water-efficient showerhead. They're inexpensive, easy to install, and can save you up to 750 gallons a month.
- Run your clothes washer and dishwasher only when they are full. You can save up to 1,000 gallons a month.
- Water plants only when necessary. Adjust sprinklers so only your lawn is watered. Apply water only as fast as the soil can absorb it and during the cooler parts of the day to reduce evaporation.
- Teach your kids about water conservation to ensure a future generation that uses water wisely. Make it a family effort to reduce next month's water bill!

FIX A LEAK!

- Pittsylvania County customers are responsible for all water usage on their side of the meter.
- The average household's leaks can account for more than 10,000 gallons of water wasted every year, or the amount of water needed to wash 270 loads of laundry.
- Common types of leaks found in the home include worn toilet flappers, dripping faucets, and other leaking valves. All are easily correctable.
- One way to find out if you have a toilet leak is to place a drop of food coloring in the toilet tank. If the color shows up in the bowl within 15 minutes without flushing, you have a leak. Make sure to flush immediately after this experiment to avoid staining the tank.
- If your toilet is leaking, the cause is often an old, faulty toilet flapper. Replacement of the whole rubber flapper is a relatively easy, inexpensive do-it-yourself project that pays for itself in no time.
- A leaky faucet that drips at the rate of one drip per second can waste more than 3,000 gallons per year.
- A leak in your main supply line or irrigation system as small as 1/32 of an inch in diameter (about the thickness of a dime) can waste about 6,300 gallons of water per month.

ADDITIONAL INFORMATION FOR LEAD

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Pittsylvania County is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using the water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. SODIUM

There is no state or federal MCL for sodium. Monitoring is required to provide information to consumers and health officials that are concerned about sodium intake due to dietary precautions. The sodium level in the Vista Pointe water system was 87.6 mg/L as tested in February of 2020.

MICROBIOLOGICAL CONTAMINANTS

Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially-harmful, bacteria may be present. Pittsylvania County is pleased to report that there were <u>no detections</u> of e-coli bacteria in the monthly samples collected during calendar year 2021.

VIOLATION INFORMATION

Vista Pointe Acres <u>did not</u> receive any monitoring violations during the 2021 calendar year.

WATER QUALITY RESULTS TABLE

In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. The following table lists those drinking water contaminants that had some level of detection and that we are required to test for. Although many more contaminants were tested, only those substances listed below were found in your water. All sources of drinking water contain some naturally occurring contaminants. At low levels, these substances are generally not harmful in our drinking water. Removing all contaminants would be extremely expensive, and in most cases, would not provide increased protection of public health. A few naturally occurring minerals may actually improve the taste of drinking water and have nutritional value at low levels.

Unless otherwise noted, the data presented in this table is from testing done in the calendar year of the report. The EPA or the State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants do not vary significantly from year to year, or the system is not considered vulnerable to this type of contamination. As such, some of our data, though representative, may be more than one year old. In this table you will find terms and abbreviations that might not be familiar to you. To help you better understand these terms, we have provided the definitions below the table.

The U.S. Environmental Protection Agency sets MCLs at very stringent levels. In developing the standards EPA assumes that the average adult drinks 2 liters of water each day throughout a 70-year life span. EPA generally sets MCLs at levels that will result in no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-one-million chance of having the described health effect for other contaminants.
