I. Call to Order:

Meeting called to order by Hite at 5:30 P.M.

II. Roll Call:

IDA roll call by Robertson. All IDA members present.

III. Approval of Agenda:

Motion by Anderson, seconded by Haymore, to approve Agenda, moving VI(B) before VI(A). Motion carried unanimously.

IV. Approval of Meeting Minutes (October 11, 2016)):

Motion by Faucette, seconded by McMahon, to approve October 11, 2016, IDA meeting minutes. Motion carried unanimously. November meeting was cancelled.

V. Review of Financial Statements (November and December 2016):

IDA Regular Checking Account balance as of November 8, 2016, was \$320,049.72. IDA Regular Checking Account balance as of December 8, 2016, was \$319,652.00. Axxor Debt Reserve Account balance as of November 8, 2016, was \$293,289.68. Axxor Debt Reserve Account balance as of December 8, 2016, was \$298,980.14. BB&T Loan Account balance as of November 8, 2016, was \$1,554,971.94. BB&T Loan Account balance as of December 8, 2016, was \$1,548,558.03.

VI. New Business:

A. Annual Oath of Officers (Hon. Mark Scarce, Clerk of Court):

As required by Article IV. of the IDA's By-laws, all IDA Directors were sworn in by Scarce.

B. Introduction of David M. Smitherman New County Administrator:

Motion carried unanimously. Motion by Anderson to re-elect Simpson as Sec./Treas., seconded by McMahon. Motion carried unanimously. 2017 IDA Officers are as follows: Hite; Chairman, Mahan; Vice-Chair, Simpson; Sec./Treas.

D. By-Laws Adoption:

A redlined copy of the IDA By-laws, with recommended revisions by Hunt, was presented the IDA for adoption. Motion by Haymore, seconded by McMahon, to adopt the By-laws with recommended revisions. Motion carried unanimously.

E. Set 2017 Meeting Dates:

IDA meetings will be held on second Tuesday of each month at 6:00 p.m. Motion by Anderson, seconded by Mahan, to adopt the meeting schedule as presented. Motion carried unanimously.

F. Review IDA Annual Budget:

IDA reviewed its budget. The IDA Clerk will request addition funds be added to the travel line to cover reimbursement for IDA Board members' travel expenses. Also, Clerk will continue to request reimbursements of IDA Clerk's salary and IDA Board members' stipends.

G. Discuss Statement of Economic Interest form (Due January 17, 2017):

Hunt explained to the IDA the new VA COIA form filing process as required by the Virginia Code.

STIPEND RESOLUTION

WHEREAS, Article III(3) of the Pittsylvania County Industrial Development Authority's ("IDA") By-Laws, states that the IDA "may receive a stipend and be reimbursed for necessary traveling and other expenses incurred in the performance of their duties, subject to the approval of the [the IDA's] Board of Directors;" and

WHEREAS, said stipend is required to be set annually, via Resolution, following an affirmative majority vote of the IDA's Board of Directors at the annual meeting, held on the second Tuesday in December of each year.

NOW THEREFORE, BE IT RESOLVED BY THE IDA, that the 2017 Annual IDA member stipend shall be \$600.00; said IDA stipend shall be paid regardless of meeting attendance; and

BE IT FURTHER RESOLVED, that IDA members acknowledge and agree that habitual IDA meeting non-attendance issues may be reviewed by the Pittsylvania County Board of Supervisors for potential corrective action measures; and

BE IT FINALLY RESOLVED, that IDA members shall also be reimbursed for necessary traveling and other expenses incurred in the performance of their official IDA duties, subject to IDA Board of Directors approval.
