b. Board of Supervisors Communications

Vic Ingram expressed gratitude from the Board of Supervisors. Continuing to help fund. Also spoke about the contingencies fund, it is money set aside for things that are not appropriated. They are trying to fund departments as much a reasonably possible.

c. FY23 Fire and Rescue Service Agreement - Chris Slemp

At the April 2022 meeting of the FRC, the FY23 Fire and Rescue Service Agreement was reviewed and discussed. The FRC voted to approve a final draft to send to the Board of Supervisors for adoption. At the May 2022 Board meeting, the document was discussed and sent back to the FRC for consideration of two items.

Board members would like to see the document contain some reference to how volunteers who may have had serious medical condition cleared to return to active status. Staff feels this is better handled by way of an overall policy instead of wording in the service agreement. A policy has been drafted and sent to the Fire and Rescue Association to review. Additionally, the board would like to see B(6)(b) contain a minimum amount of call coverage.

D. Fowler spoke for Fire and Rescue Association, stated they wanted to table the drafted policy on return to active status. Concerns on how to "police" this, some may go out for a medical reason and the Chief of a department may not ever know anything about it. He had spoken with the insurance provider.

Discussion was had about the service agreement and including the policy.

B. Meeks spoke about separating the two topics and creating an Ad hoc committee to look at the medical policy. Benchmark is still 70% to get funding and dropping below 50% funding would be reduced.

g. Drug Box changes/exchanges

Chris Christenson spoke who works for the Virginia EMS council. The Board of Pharmacy issued a guidance document earlier this year that each locality and or agency had to obtain a controlled substance registration. That can no longer fall under the regional registration. The rescue association decided for the county to submit then each agency add an addendum. One application and application fee. Everyone across the state is out of compliance. Inspections by board of pharmacy was discussed and the requirements. The way that the drug box systems works right now in the state may no longer be in compliance with the DEA regulations when they come out also. There are 550 drug boxes across the state that move between 15 different hospitals. VA is exploring options with the drug boxes at this time, may have to potentially assign drug boxes to specific pharmacies. Currently no changes, just for awareness at this time. What has to be done is the controlled substance registrations across the state, and they are working to get everyone in compliance.

- D. Fowler advised that the Fire & Rescue Association discussed this, and a motion was made and approved to go with the county apply and then each agency do an addendum.
- C. Key stated there is a lot of research that is going to go on with this and it is not going to be a quick easy fix.

SUMMARY:

At the Board of Supervisors' ("Board") March Business Meeting, the Board decided the following issues related to the County's Volunteer Fire and EMS Agencies:

1. <u>APRA Applications:</u> The Board approved ARPA application and projects for the following departments:

Callands Fire and Rescue Station HVAC upgrades \$2124.21

Laurel Grove Fire Dept Down payment on apparatus \$26,727.79

Hurt Fire Department Debt Service on Station \$43,000

Mt. Hermon Fire and Rescue Lost Revenue & Station upgrades \$43,000

Mt. Cross Fire Dept Fire Equipment & PPE \$11,065.83

- **2. FY23 Fire and Rescue Service Agreement:** The Board reviewed the FY23 Fire and approved the agreement with the understanding a policy regarding returning to active volunteer duty after major medical condition is adopted by the FRC.
- 3. <u>EMS Billing Rates:</u> The Board approved a public hearing at the July 2022 meeting regarding the request for EMS billing rate changes.
- **4.** Request for additional fire and rescue funding: The Board heard the following request for funding concerning fire and rescue agencies:
- A. Heard a request to move \$24,000 in the current FY22 budget and redistribute it among the volunteer agencies. The Board approved this request and agreed to give single service agencies and additional \$750 and dual service agencies \$1500.
- B. Heard a request to add an additional \$24,000 to the FY23 budget to adequately fund the volunteer funding matrix. The Board approved this request.

- C. Heard a request to add \$91,000 to the FY23 budget in order to give each volunteer agency an increase in base amounts. This would have to come from the FY23 contingency funds and because of this the request was tabled for now due to many other potential funding issues in FY23.
- D. Heard a request to add an additional \$77,500 to the FY23 budget in order to increase the EMS pay per call from \$15 to \$25 a call. This would have to come from the FY23 contingency funds and because of this the request was tabled for now due to many other potential funding issues in FY23.
- E. The Board recognized Cascade Fire and Rescue Department for their award from the Western Virginia EMS Council as the Outstanding EMS Agency of 2022.

Purpose:

Our Fire and Rescue System is dependent on personnel to carry out our mission. Our dedicated members are both our most valued and most costly asset to protect and support. Replacing and retaining quality members, both volunteer and career, is a daily struggle for most agencies. These same members are in control of other large, expensive, and risky assets of the department and are asked to operate them under extreme conditions. We should be concerned about the health and safety of our members first.

Volunteer Fire and Rescue members function in non-traditional work environments full of dangers that place these providers at increased risk of injury on a daily basis. To illustrate this, the National Fire Protection Association (NFPA) reports the American fire service suffered an estimated 69,400 injuries in 2012 (Karter & Molis, 2013) and the National Association of Emergency Medical Technicians (NAEMT) reports EMS practitioners are seven times more likely than the average worker to miss work as a result of injury (American Council on Exercise, 2012).

Medical or health conditions, whether incurred on the job or on personal time, can prevent a member from functioning at a full-duty level. It is not unusual for the injured member to want to return to duty as soon as they begin feeling better. However, returning prematurely to the unpredictable work environments encountered can lead to an increased risk of further injury or death. It is imperative the member reaches a full level of functionality before returning to full-duty.

Scope:

This guideline shall apply to all those who are participating in the Pittsylvania County Fire and Rescue system as active responders.

Definitions:

A serious health condition is defined as an illness, injury, impairment, or physical or mental condition which requires:

- Overnight hospitalization (including prenatal care), including the period of incapacity or subsequent treatment in connection with the overnight care;
- Or that involves continuing treatment by or under the supervision of a health care provider or a provider
 of health care services and which includes any period of incapacity (i.e., inability to work, attend school or
 perform other regular daily activities).

Guideline:

Not all medical conditions require a complete rehabilitation program before a member can return to active status. For example, an uncomplicated case of the flu may require a few days off from active status but does not require the member to undergo rigorous return to duty scrutiny. However, a serious health condition can be one in which the member is unable to perform their duties as a result of a health condition. In such case(s) when known by the Chief of the agency, he/she shall require that the member be medically cleared by a medical doctor prior to being allowed to return to active duty and responding to emergency calls.

SUMMARY:

Currently Virginia's EMS agencies rely on area hospitals, working in conjunction with local EMS Councils, to provide drugs and drug boxes for all highly controlled substances. Locally, the County also keeps lessor-controlled substances in stock and has other controls to track and administer these medications. Virginia is the only state to still use a drug box exchange program. Recently, the Public Safety Department has been made of aware of changes coming from the Board of Pharmacy that will lead to sticker controls of medications. Additionally, the DEA is revising their rules and regulations that could bring serious changes to the drug box exchange program. Chris Key and Kasey Seay will lead a discussion and updates concerning the future of our medication procedures and the possible financial situation this may bring.
