DESIGNATED INDIVIDUAL: A person who is in possession of a BCC issued by the SFMO, certified by the SFMO as a pyrotechnician, or a restricted or unrestricted blaster, any of whom are responsible for ensuring compliance with state law and regulations relating to blasting agents and explosives and applying for explosives or firework permits; is at least 21 years of age; and demonstrates the capability to effectively communicate safety messages verbally and in writing in the English language.

**CONDITIONS OF PERMIT ISSUANCE:**

By my signature below, I attest the information provided is complete and accurate. I acknowledge and agree to comply with all applicable requirements of the Virginia Statewide Fire Prevention Code (SFPC) and the referenced NFPA 1123-10 standard governing the use, storage and firing of display fireworks, even those not specifically covered or expressed on this application. I also acknowledge that if a permit is issued it shall:

1. Be valid only at the location listed on the application, and for the specific date and time for which it is issued; and
2. Does not convey approval to store explosives (display fireworks) beyond the temporary (less than 24-hour) on-site storage of the display fireworks on the date of the approved display.

If approved to proceed, I acknowledge that such approval is conditional upon continued compliance with the SFPC. I further acknowledge and understand that any SFPC violations identified after provisional approval to proceed may result in denial of final permit issuance or immediate suspension or revocation of a permit.
