Over the past few weeks, it has been a lot better.

3. Sheriffs Dept. Tabletop exercise - April 6, 2023, at 1pm at the Old Dominion Ag Complex. The purpose of this training is to understand what each agencies capabilities are during a mass casualty event. The school system along with other jurisdictions will be participating. They want to have EMS personnel at each table to explain your processes when dealing with different levels of trauma, and protocols in place. They are asking for 20 people.

- a. Board of Supervisors Communications, Vic Ingram spoke about the county's budget calendar.
- b. Budget discussion Chris Key lead discussion on the Fire and Rescue FY24 budget, it was presented to the finance committee and the County Administrator on January 23, 2023. All presented as one.
- c. Fire and Rescue Memorial update Ben Meeks spoke about the project presentation to the board was stopped due to the property being managed by the school system. The Ad Hoc committee is meeting February 21, 2023, at 5p at Public Safety building. Vic Ingram spoke about the county owning the property the school board manages the property.
- d. Discussion of Radio Replacement, Director Key spoke about the portable radio replacement. There is no one radio that will talk to every county surrounding ours. Radio technicians are working on talk groups. CIP request in FY24 budget to replace 100 portable radios/per year at cost of \$1,300.00 each for a total cost of \$130,00.00/year.
- e. Chris Key spoke about the Controlled Substance Registry of schedule 6 drugs. Counties inspection was Monday February 6, 2023. They are waiting on results. Insurance would cover under malpractice, but no fines would be covered.

Fowler spoke about the Agencies intend to apply for CSR.

- f. Insurance policy for Fire & Rescue, Kermit King spoke about insurance committee meeting yesterday with Mark Bowery VFIS representative. They will have to continue to meet and go over the policy, the policy renews in FY2025.
- g. ARPA funding, Dean Fowler spoke about status of the left-over ARPA Funding (\$11,588.45) from the Fire and Rescue Association meeting, it was recommended that we try to put into place a Countywide accountability system with the left-over funds. To have a countywide system, training, and triage system.

Fire and Rescue Standard Operating Guidelines

Subject	Fire and Rescue Operational Radio Procedures
SOG Number	Operations - 11
Effective Date	June 1, 2021

Purpose:

To establish a standard operating guide for Volunteer and Career Pittsylvania County Public Safety personnel operating on fire and rescue scenes to communicate over the Public Safety Radio System in an effective and orderly manner.

Scope:

This standard operating guideline shall be applicable to all personnel operating within the Pittsylvania County Public Safety System.

Procedure:

- When an agency is dispatched to a fire or EMS call (for service, the agency should utilize their station or squad talk group to advise they are enroute, then one) member of the agency should advise CECOM the call is covered once <u>adequate</u> staffing is available.
- On smaller single agency response incidents, departments are encouraged to use their department talk group for communications on the event for things such as traffic control.
- On incidents involving more than one department responding, CECOM will assign a TAC channel. Agencies responding should mark enroute to the call and on-scene of the call on the CECOM channel. When a Tac channel is assigned, all responding units will advise they are responding on CECOM channel and they are switching to the assigned TAC channel. Once on the TAC channel, responding units will check in on the TAC channel (Ex: Engine 342 is on TAC 4) with no acknowledgement needed from CECOM or Command. Radio traffic on TAC channel should be kept to pertinent/necessary traffic only (EX: giving size up, marking on scene, asking command for assignment). Once arriving on scene, members should switch to the assigned Tac channel and utilize that channel for the duration of the incident.
- All unnecessary radio traffic should be kept off CECOM and TAC channel. If units enroute need
 directions or if on scene units need to communicate non priority messages (Ex: water supply, traffic
 control, or other traffic) they should utilize first due departments talk group or ask for another TAC
 channel.

- When incidents require the use of a TAC channel, dispatchers shall monitor that TAC channel until the
 incident is marked "under control" by the incident commander. Once "under control" the members on
 scene shall continue to use the TAC channel but CECOM will not be monitoring. The incident commander
 will need to switch over to CECOM for any necessary radio traffic with the dispatch center.
- When fire and rescue agency responses are cancelled by dispatch or incident command, the dispatch center shall send out a page informing agencies to cancel their response.
