The Electoral Board of Pittsylvania County met on Tuesday, November 14, 2017, at 10:00 a.m. to complete the canvass of the vote of the November 7, 2017 election. All members of the Board were present as well as the General Registrar and Assistant Registrar. Mrs. Barbara Hancock, candidate for the Callands-Gretna Board of Supervisors, was also present. Mrs. Gilbert called the meeting to order at 10:25 a.m.


Ms. Bailess advised the Board that the provisional ballot for presenting an ID did not send or bring in any form of identification and therefore, the ballot was denied. The other provisional ballot was from Climax #206, Kristal Harris. Her votes were added to the count sheets and the final vote totals were certified as follows and copies of the Abstract of Votes for each race are attached to and made a part of these minutes.

The race for the Callands-Gretna Board of Supervisors race was separated by only 14 votes and Ms. Bailess advised Mrs. Hancock that she has the right to ask for a recount and must do so within 10 days of the Board's certification of the vote. She also addressed Mrs. Hancock as to what documents she can review from the election and that Pittsylvania County will be responsible for the cost of the recount due to the fact that there is less than 1% difference. At this time, Mrs. Hancock left.

Ms. Bailess then addressed the Board concerning the potential voter fraud at #207, Gretna High School. She had requested the vendor with the pollbook company to load the files of #207 and she said that at 9:08 a.m. the gentleman in question attempted to check in and the process lasted for 50 seconds; a second search for this same person was performed again 20 minutes later and lasted 30 seconds and a third attempt took place at 11:20 a.m.; his license scanned and submitted an ID. This attempt lasted 17

seconds. This individual is registered to vote at #309 Gretna Elementary School which is in Bannister District and not Callands-Gretna District. SBE had advised the Registrar and Board that the Commonwealth Attorney's Office should be contacted, and the evidence provided to him to determine whether to proceed.
