The Electoral Board of Pittsylvania County, Virginia, met on Wednesday, November 9, 2016, at 10:0 a.m. All members of the Board were present as well as Kelly Bailess, Registrar, and Tammy Moore, Assistant Registrar. The purpose of the meeting was to canvass the vote of the November 8, 2016 election.

Ms. Arthur made a motion to go into Executive Session to review the provisional ballots cast on Election Day, seconded by Ms. Gilbert and unanimously approved. The Board went into Executive Session at 10:010 a.m. The Board came out of Executive Session at 12:20 p.m. and stated that after review of the provisional ballots, 15 ballots were counted, 23 were not counted and 2 require a photo I.D.
