The Electoral Board of Pittsylvania County, Virginia, met on January 21, 2020, at 10:15 a.m., in the office of the Board in Chatham, Virginia. All members of the Board were present.

The first item of business was the reorganization of the Board for 2020. Mrs. Arthur proposed that the officers remain the same. Mr. Terry seconded the motion and it was unanimously approved. The officers are Mrs. Sandra Gilbert, Chairman; Mr. Lester Terry, Vice Chairman and Mrs. Brenda Arthur, Secretary.

Under old business, Mrs. Gilbert said that she had had complaints on campaign people were getting closer than 40 feet to the entrance of several precincts, and we needed to work on that.

The November minutes were not available because of issues with the printer in the Board office. Mrs. Keesee is trying to get a new printer for us.

At this time, Mrs. Keesee joined the meeting. She had information concerning the meeting at the Homestead March 20-22, 2020. None of our Board members were interested in going. We all agreed having been to these meetings, we consider it a total a waste of time and money. Mrs. Keesee then reported that we have a deficit of \$34,000 with 2 EXTRA elections in 2020.



Mrs. Keesee then advised the Board that Senate Bill 111 for 45-days out "no excuse voting" has passed. This is for EVERY election. It takes the place of "absentee" voting. The cost for this will be considerable due to the additional machines, pollbooks, etc. will be necessary to handle this; more staff, satellite locations. She was guessing 6 new machines, ADA machines and Pollbook (Laptops). The County is required to pay for things that we MUST HAVE PER STATE LAW. The State reimburses this on a

50/50 total cost. The work load is to the point now that she needs another "full time" person in the office.

There being no further business to come before the meeting, the same was adjourned at 12:15 p.m.
