# Team Meeting Minutes March 23, 2023 Pittsylvania County Community Center

#### I. Call to Order

#### IV. Approval of Agenda:

A. Agency Updates - DPCS; Ms. Irby shared that Ms. Girten was in Texas with her husband who had recently undergone a successful surgery. She would be working from Texas for the next 4-6 weeks. There has also been an application for a clinician and Ms. Irby is very hopeful the applicant will meet the criteria to be hired by DPCS.

Ms. Boswell and Ms. Barger spoke about the QRTP Process and how it has recently been stopped by the state due to problems is has been causing. It will be restarted again at some point, but when the state feels it can be more efficiently implemented. Until that time, QRTP's will be CSA funded. Ms. Barger shared they had submitted a request to be reimbursed for the local funds spent on QRTP's but has not heard back from the state as of yet.

- **B.** Administrative Memo 23-02- Ms. Boswell shared the memo from the state referenced SpEd Wrap funding. Pittsylvania County CSA currently gets a small allocation of funding, but if it is spent, CSA can ask for more. Last year CSA was able to spend almost the entire allocation and the hope is to do the same this year. Ms. Boswell and the FAPT Team stay on top of making sure all guidelines are followed when using SpEd Wrap funding as well.
- **C. 2020 Final Audit Report-** Ms. Boswell discussed information about the final audit. Ms. Boswell, Ms. Van Der Hyde, and Ms. Irby spoke with the state about the findings of the audit recently. Ms. Boswell shared the Quality Improvement Plan has to be turned in by 4-14-2023 and she will share it at the next CPMT Meeting.
- **D. Quarterly Reconciliation-** Ms. Boswell and Ms. Van Der Hyde have been working together on a way to compare spending and what is being collected to present the most up to date records to reflect how finances are being reconciled. Ms. Van Der Hyde commended Ms. Ritchie on how well she stays on top of things and paying invoices out. Ms. Van Der Hyde stated that our reconciliation is a close as it is going to get, and we are doing well. Ms. Boswell shared this was one of the findings out of the county audit. There were 21 audit findings of significant deficiency on social services not having a standard review over case action payments. FAPT services as the multi-disciplinary team and now has a plan in place to review those necessary cases annually, every January.
- **E.** Quarterly UM/UR Reports- Ms. Cooper shared the FAPT and Vendor survey reports. Overall, the results given show that Private Providers and FAPT are meeting the needs of the families and the children in the programs. Families are satisfied with all current services and providers.
