

Fire and Rescue Standard Operating Guidelines

Subject	Fire and Rescue Operational Radio Procedures
SOG Number	Operations - 11
Effective Date	June 1, 2021

Purpose:

To establish a standard operating guide for Volunteer and Career Pittsylvania County Public Safety personnel operating on fire and rescue scenes to communicate over the Public Safety Radio System in an effective and orderly manner.

Scope:

This standard operating guideline shall be applicable to all personnel operating within the Pittsylvania County Public Safety System.

Procedure:

- When an agency is dispatched to a fire or EMS call for service, the agency should utilize their station or squad talk group to advise they are enroute, then one member of the agency should advise CECOM the call is covered once adequate staffing is available.
- On single agency response incidents, departments are encouraged to use their department talk group for communications on the event for things such as traffic control.
- On incidents involving more than one department responding, CECOM will assign a TAC channel. When a
 Tac channel is assigned, all responding units will advise they are responding on CECOM channel and they
 are switching to the assigned TAC channel. Once on the TAC channel, responding units will check in on the
 TAC channel (Ex: Engine 342 is on TAC 4) with no acknowledgement needed from CECOM or Command.
 Radio traffic on TAC channel should be kept to pertinent/necessary traffic only (EX: giving size up, marking
 on scene, asking command for assignment)
- All unnecessary radio traffic should be kept off CECOM and TAC channel. If units enroute need directions
 or if on scene units need to communicate non priority messages (Ex: water supply, traffic control, or other
 traffic) they should utilize first due departments talk group.

- When incidents require the use of a TAC channel, dispatchers shall monitor that TAC channel until the
 incident is marked "under control" by the incident commander. Once "under control" the members on
 scene shall continue to use the TAC channel but CECOM will not be monitoring. The incident commander
 will need to switch over to CECOM for any necessary radio traffic with the dispatch center.
- When fire and rescue agency responses are cancelled by dispatch or incident command, the dispatch center shall send out a page informing agency to cancel their response.

Fire and Rescue Standard Operating Guidelines

Subject	Clinical Improvement Committee	
SOG Number	Patient Care-04

Purpose:

The purpose of this standard is to identify the process for resolutions of EMS related concerns. The quality care resolution process is only one aspect of a comprehensive quality improvement program. This process is intended to be educational and not punitive and will recognize both the positive and negative actions during an incident. The Clinical Improvement Committee shall be composed of the County's Operational Medical Director, PCPS Division Chief or one of his or her designee, one representative from each volunteer agency that operates under Dr. Kayla Long. All committee members shall be appointed annually. Other members may be assigned as needed and approved by Dr. Kayla Long or her designee.

Scope:

This standard operating guideline shall be applicable to all EMS provider's operating within the Pittsylvania County Public Safety system under OMD Dr. Kayla Long.

Procedure:

This procedure is established under the authority of the operational medical director as required by the Virginia Office of EMS rules and regulations governing emergency medical services of the Board of Health, Commonwealth of Virginia. The purpose of the Clinical Improvement Committee is to ensure that agency protocols are being followed, to limit liability exposures in documentation, to develop and make known committee expectations, to oversee the ALS-internship program, and to establish and review the agency standard of care.

Any agency or provider practicing in Pittsylvania County may submit reports for review to the OMD or PCPS Division Chief.

- Verbal Communications Resolution of a concern should be attempted between parties when it initially
 develops. Any verbal discussions are to take place in an appropriate area, away from patients or other noninvolved parties. All communications are to be professional and non-confrontational. Patient care is not to
 be adversely impacted due to an issue being raised.
- Documented Concerns If a concern was unable to be resolved in the preceding step, or when effective communications have broken down, the chief officer of the agency should submit an Incident Report to the PCPS Division Chief with a copy of the applicable PCR for review. The PCPS Division Chief will then submit the report and a copy of the PCR to the OMD for review.
- Flow of Clinical Improvement reports The OMD will review the report within seven (7) days of receipt. The
 OMD or their designee shall investigate the report as long as the investigator was not directly involved with
 the incident. The investigator will determine the facts of the case and shall work jointly with the Clinical
 Improvements Committee to formulate recommendations.

- Final Disposition The Clinical Improvement Committee shall report the results of the investigation and the final disposition to the agency OMD. The applicable OMD will review the final disposition and either signifies their satisfaction or request further consideration to the case.
- Appeal Process If a provider feels the initial complaint was invalid or is in total disagreement with the findings, they may elect to file an appeal to the Operational Medic Director.
- Discipline The Clinical Improvement identifies issues and plans a course of corrective action if necessary.
 Due to the scope of these issues, if discipline of the involved individual(s) is determined as a possibility the issue shall be then forwarded to the OMD. Discipline resulting from deviation from rules and regulations will be separate action from the Clinical Improvement Committee and the sole responsibility of the OMD.
- OMD Suspension of Providers The applicable OMD reserves the right to suspend any provider from "active" status at any time, pending ultimate resolution of the issues.

All agencies who practice under the Pittsylvania County OMD shall give access to their ESO EHR under the Pittsylvania County umbrella account.

The Clinical Improvement Committee is responsible for reviewing random Pre-hospital Patient Care Reports (PCR) from BLS and/or ALS providers within the agencies of Pittsylvania County. The committee shall develop a documented system for recording findings and the process of ticket review, including determinations rendered.

Regular meetings shall occur at least once a month until established and then transition to quarterly meetings. Additional meetings shall be at the discretion of the Operation Medical Director. Meetings may be in person, and or zoom based.

All information regarding matters in forum of the Clinical Improvement Committee shall be kept confidential to the members of the Committee and/or the provider(s) involved.

Any member involved in a Clinical Improvement Committee endorsed investigation shall be suspended from the Committee until the investigation is completed. If the member is found to be in violation of a confidentiality of the Clinical Improvement Committee, they shall be dismissed from the Committee and ineligible for re-appointment for six (6) months.

Any member dismissed from the Committee may file an appeal to the OMD within fifteen (15) days from the date of the dismissal. The OMD shall render a decision based on the facts presented and gathered in the investigation process and inform the member within fifteen (15) days of the decision. The OMD shall hold the final decision in the appeal process.

PCPS Division Chief shall upon request present to the OMD a monthly Clinical Improvement Committee Report citing any recommendations or pertinent patient care or quality concerns that need to be addressed or considered by the Panel.

Clinical Improvement Committee written documents must be kept confidential and secured and are subject to inspection based on the investigating jurisdiction as approved by the PCPS Division Chief.
