# VI. New Business:

- A. Agency Updates DPCS; Ms. Irby shared DPCS have hired a new telehealth clinician but is still in need of another clinician; PCS; Ms. Cassada shared that the next Health Collaborative meeting would be next Tuesday 06/27/2023 @9AM; Health Department; Ms. Waller shared that PATHS will be having mobile clinics for 7th and 12th grade mandated vaccinations; Sheriff's Department; Sheriff Taylor spoke about the July 31st Active Shooter Training that is scheduled. SOVAH, Centra and First Rescue are all involved with this training.
- **B.** Audit Findings- Ms. Boswell received the findings from the audit on 5-9-2023. She has met with Ms. Hunt (County Attorney), Mr. Turille (County Administrator), and Ms. Van Der Hyde (Director of Finance). Ms. Boswell has completed an update to the Board to explain why there is a recoup of monies (\$33,449.93) and what has been put in place to prevent it in the future.
