#### **COUNTY STAFF REPORTS**

County's Public Safety Director's Report (Christopher Key)

#### **Summary:**

- 1. ATL funding Should receive the FY24 money from the state in Sept/Oct.
- 2. Four for Life Funding packets have been passed out to each agency for FY24. Due back in March
- 3. Roasters Need roasters turned in from every department for 2023.
- **4.** Expenditure reports Need them turned in from every department for FY23 expenses from disbursements.
- 5. <u>Training</u> Active Shooter exercise on July 31, 2023, at Gretna Middle School was a successful training opportunity. 2 Firefighter 1 classes starting up one in Gretna, one in Blairs. EVOC class and Extrication calls coming up. Along with a Solar Farm class.
- 6. <u>Risk Reduction</u>: On Friday June 23, 2023, a rep from VFIS Insurance was here to conduct a risk control survey and visited the following stations: Chatham FD, Blairs F&R, Tunstall F&R, Mt Cross FD.
- Haz Mat Officer Welcome Jason Curtis as the new Haz Mat Officer to VDEM Region 3 located in our Region 6.

Insurance is recommending physicals. There is no money in this year's budget for them, hope to include that in next year's budget.

#### **NEW BUSINESS**

- a. Board of Supervisors Communications, Vic thanked everyone.
- b. Fire & Rescue service agreement Director Key spoke about the agreement was presented and voted on in the July Board meeting. Was distributed to the agencies July 21<sup>st</sup>. There were a few changes in page 3 of 7 Section B 8 and B 9.
  - D. Fowler spoke about item 9 at the Fire and Rescue Association meeting, complaints being sent to the Public Safety Director within 48 hours. Having the Director work with the Chief of that Department. The OEMS, OMD, and agency has been handling this with the Public Safety Director.

Meeks spoke about the wording of notifying the county when there is a complaint. They were not notified of any purposed changes. Stated that the association and commission was left out of these changes.

Turille, County Administrator spoke about the process. He is still in the process of learning over the past 4 months. There is a different process that the Board wants this year. He was unfamiliar with the process. Pulled together with the OMD situation. Audit, the Board just wants to make sure everything is okay. Spoke about the expectations of spending taxpayers' dollars. Just a Certified Letter is all they are looking for from an Accountant. He also spoke about the complaints. Respects the way complaints are handled and wants them handled in house and professionally. A lot of good work has been done. Over 18,000 calls in 2 years and only 7 complaints. Any complaints that effect the professional delivery of public service. The county just wants to know before it hits the street. We will work it out with trained professionals. This is a partnership.

- D. Fowler advised that if the Administrator will contact the Chief and handle it this way, he feels that the Association will be okay with this.
- V. Ingram advised that the County Attorney assisted in drawing up the wording on the complaints section. The county needs to know of complaints. He spoke about audits and auditing every department. He has faith in leadership managing departments. Just request a letter from a CPA stating everything is accounted for.
- A. Casper agreed we are here for the same reason and treat everyone with respect.

Turille stressed the importance of improving communication and we all have the same goal.

- c. Fire & Rescue memorial Ingram spoke about this, and it is a work in progress, and it is a total revamp and will have more definite plan at the next meeting.
- d. Fire & Rescue billing rates Meeks spoke about the Medicare allowable billing has increased. Fowler advised the Association committee is still working on reviewing the rates from surrounding areas. Needs to be reviewed every October.
