CHAPTER 14

PUBLIC BUILDINGS AND PROPERTY

SEC. 14-1. THE OLD CLERK'S OFFICE.

Resolved that this Board acquire for the County of Pittsylvania by deed of gift from Landon E. Oakes. The building and real estate situate at Callands, Virginia, generally known as "The Old Clerk's Office" where the Courthouse and County Seat of said County was located at Callands, pursuant to Section 15.2-944, Code of Virginia, as amended, it being of historical interest and value to said County and the Commonwealth; and

To create an authority to constitute a Board of Trustees, the members of which are to be designated and appointed by the Board of Supervisors of said County, such terms and with such numbers, as the Board of Supervisors may decide, to preserve said historical site after same has been restored by such agent or agents as the Board of Supervisors may appoint, authorize and designate. (B.S.M. 6-30-66)

SEC. 14-2. COUNTY GASOLINE.

On motion it is ordered that the following resolution be adopted and a copy of same delivered to each of the County foremen, managers, and superintendents and employees in charge of County property.

Resolved that no employee of the County of District shall sell, loan, or give away gasoline, oil or personal property belonging to the County nor shall such employee be authorized to use same in any private car, automobile, truck, or tractor for any private purpose.

An Ordinance of the County of Pittsylvania, Virginia providing that the Code of Ordinances of Pittsylvania County, Virginia be amended by adding a section providing for the orderly control and operations of Wayside Park.

Be it ordained by the Board of Supervisors of Pittsylvania County, Virginia as follows:

SEC. 14-3. REGULATIONS FOR THE OPERATION OF "WAYSIDE PARK" AT HURT VIRGINIA.

- (a) Hours of operation shall be from 7:00 a.m. until 10:00 p.m.
- (b) Speed limit throughout the park shall be no more than five (5) miles per hour.

- (c) It shall be unlawful to place any trash outside of the trash receptacles.
- (d) It shall be unlawful for any person to drop, deposit, discard, or otherwise dispose of litter in or upon any portion of the park except in public receptacles provided for public use (reference Chapter 33, Article II, Section 12 of Pittsylvania County Code of 1976, as amended).
- (e) It shall be unlawful for anyone to cut, pick or remove any flowers, foliage, arbor or trees from any area in the park.
- (f) Parking is permitted in designated parking areas only. It shall be unlawful to park on grass, picnic areas, playgrounds, baseball fields or under picnic shelters vehicles will be towed at owner's expense.
- (g) It shall be unlawful to block the flow of traffic in any matter or form vehicles will be towed at owner's expense.
- (h) Grooming and maintenance of motor vehicles is prohibited within the confines of the park.
- (i) Mopeds, min-bikes, three-wheeled motorcycles and four-wheeled motorcycles are prohibited from operations within the confines of the park.
- (j) Swinging and forceful swaying of the bridge crossing over Sycamore Creek is strictly prohibited.
- (k) The Board of Supervisors may by permit authorize special use of the park for group functions. Application shall be made through the Office of the County Administrator.
- (1) It shall be unlawful for any person to set fire to, or procure another to set fire to, any woods, brush, logs, leaves, grass, debris or other flammable material within the boundaries of "Wayside Park" except in designated bar-be-que facilities provided for public use (reference Chapter 27, Sec. 1-1 of Pittsylvania County Code of 1975, as amended).
- (m) An adult must accompany children under twelve (12) years of age.

SEC. 14-4. SEVERABILITY IN PART.

If any part, section, subsection, sentence or phrase of this Article is, for any reason, declared to be unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Article.

SEC. 14-5. EFFECTIVE DATE.

This article shall be effective upon its passage.

SEC. 14-6. PENALTIES AND OTHER LEGAL ACTIONS.

Violations of sections of this ordinance deemed to be unlawful shall be deemed a misdemeanor and upon conviction shall be subject to a fine not exceeding on thousand (\$1,000) dollars or thirty (30) days in jail for each violation or both.

Violations of sections of this ordinance deemed to be prohibited shall be punishable by expulsion and or restriction from the park for up to the entire operating season.
