IV. Approval of Agenda:

Ms. Irby asked if anyone had any additions or corrections to the agenda. Ms. Van Der Hyde made a motion for the agenda to be approved and Ms. Cassada seconded the motion. Motion passed.

Ms. Van Der Hyde made a motion to approve the September 2023 minutes and the September 2023 Pool Report. The motion was seconded by Sheriff Taylor. Motion passed.

VI. New Business:

- A. Agency Updates PCS; Ms. Cassada shared the schools were working to build better communication between the school and families along with utilization of the mobile health clinics. Ms. Cassada shared they schools were utilizing nursing staff in the school settings to help with bridging some of those gaps. There were no other agency updates.
- **B.** Approval of August Minutes and Pool Report- Ms. Boswell shared at the last meeting that the Team re-approved the July Minutes and Pool Report and to have it recorded in the minutes, the Team would need to vote to approve the correct August Pool Report and August Minutes. Ms. Van Der Hyde made a motion to approve, and Sheriff Taylor seconded the motion. Motion passed.
- C. Updated Foster Care Rates With 5% Increase- Ms. Boswell shared the CSA office initially approved the 5% increased rate and then the state rescinded, and CSA then changed all of the Purchase Orders back to the original rate. Since the last CPMT meeting, the state has reapproved, and retro dated the change to July 1, 2023. Ms. Boswell is working to rectify the Purchase Orders to the original 5% increase. The other problem is Ms. Ritchie has already started paying out of the Purchase Orders and there may have to be some funding for the difference to accommodate where payments have already been made. Ms. Boswell plans to have all of these changes on the November Board sheet.
- **D. Administrative Memo#23-10 -** Ms. Boswell shared this was memo to state that Private Day requires a consent to release information on file for each child being served in the Private Day setting. This is already Pittsylvania County's Policy.
- **E. IACCT Changes-** Ms. Boswell shared there were changes being made around the IACCT process. Magellan will no longer be facilitating those meetings or processes. The new processor is Keypro, and they have already sent out contact information to Ms. Boswell and she has already shared with the Team. The process should not change, only the people handling it. Ms. Cooper will also check the web link to make an inquiry after November 1 to see if the link still works and share the outcome.
- **F. Quarterly Reimbursements-** Ms. Van Der Hyde shared with the Team that she and Sandy have been comparing information from Thomas Brothers, OCS Website, and the County Auditors to be sure all of the

At this time, all totals are a match to the penny and Ms. Van Der Hyde feels confident with the numbers and speaks very highly of the work Ms. Ritchie does and how efficient she is with keeping the CSA Office on top of their financials.
