### Fiscal 2025 Budget Calendar

**Special meeting** Tuesday, March 12, 4 p.m. County Administrator Stuart Turille will submit the recommended budget to the Pittsylvania County Board of Supervisors in the Board meeting room, 39 Bank St., Chatham. The budget and tax rate will be considered for approval to be advertised. The meeting will be broadcast on the County's Facebook page and its YouTube channel.

**Advertisements for public hearings** on the County budget and tax rate is scheduled to be advertised on Wednesday, March 20.

**Public hearings** to be held Thursday, March 28, 7 p.m. for potential School budget and full County budget in the Board meeting room, 39 Bank St., Chatham. The budget cannot be approved until 7 days after the public hearing.

**Special meeting** Thursday, April 4, 5 p.m. for the Board of Supervisors to approve the tax rate, School budget and full County budget.

## **June Primary Order Issued**

# **COMMONWEALTH of VIRGINIA**

#### To the Secretary of the Electoral Board:

WHEREAS a notice in proper form has been received from the appropriate authority requesting the calling of a Primary Election for the purpose of nominating a candidate for the **Democratic and Republican Parties** for the **offices of Member**, **United States Senate**, **Member**, **House of Representatives and local offices. This certificate serves to notify you of said primaries which are attached for all localities**. Should only one candidate qualify for the primary ballot in any office, no primary for that office will be held.

THEREFORE, you are, in the name of the Commonwealth and pursuant to § 24.2-517 of the *Code of Virginia*, ordered to cause a Primary Election to be held in your county or city on Tuesday, June 18, 2024, for the purpose aforesaid. You are further ordered to post a copy of this order on the official website of the county or city, at not less than 10 public places in the county or city, or have the order published at least once in a newspaper of general circulation in your locality.

## **Procurement Fair Scheduled**



The City of Danville will host the Southern Virginia Regional Procurement Fair on April 10, to provide an opportunity for local businesses to meet with government and private sector buyers of supplies or services.






Pittsylvania County's first responders answered the call to service this week, saving the lives and property of the County's citizens. EMS responders answered 211 primary calls for service between February 29 – March 6. Of those, volunteers responded to 170 of those calls – or 81%. Pittsylvania County

Public Safety were the primary responders on 41 of those calls, or 19%, and outside agencies took six.

The County's fire departments responded to 50 fire calls during that same period.





# Reminder

# 4 PM BURNING LAW IN EFFECT

FEBRUARY 15th - APRIL 30th

# MAXIMUM FINE \$500.00 BURNING LAW IN BRIEF:

- 1. No burning until after 4:00 p.m. if the fire is within 300 feet of woodland, brushland, or field containing dry grass or other inflammable material.
- 2. Fire must be attended at all times if the fire is within 150 feet of woodland or other dry fuel leading to woodland.
- 3. No fuel may be added or fire started after midnight.
- 4. Law applies to campfires, warming fires, brush piles, household trash, stumps, fields of dry grass and brush, or anything capable of spreading fire.

#### RT. 41 – FRANKLIN TURNPIKE <u>VDOT TRAFFIC STUDY</u>



#### MONDAY, MARCH 25, 5:30 p.m. Mt. Hermon Volunteer Fire Dept. 4268 Franklin Turnpike Danville, VA

The public is invited to attend a community meeting to provide input and receive information from VDOT regarding the "Project Pipeline" study of Rt. 41 Franklin Turnpike that began in May 2023 and is due to be completed in July 2024.

The purpose of this "Project Pipeline" study is to identify potential solutions to safety issues on Franklin Turnpike. The suggested improvements generated by this study can be used to apply for funding through VDOT's "Smart Scale" program, which evaluates and prioritizes potential projects based on key factors like how they improve safety, reduce congestion, and contribute to economic development.

Supervisor Ken Bowman, Chatham-Blairs District will be on hand, along with other county supervisors and VDOT representatives, to listen to citizens and business owners of the Mt. Hermon commercial corridor.
